Denmark and New Zealand have cornered the top spot, followed by

Finland, Singapore, Sweden and Switzerland in the top ten².according to the non-government group's report, even in democracies, such as Australia and India, unfair and opaque political financing and undue influence in decision-making and lobbying by powerful corporate interest groups, result in stagnation or decline in control of corruption.

According to few author the definition of protests are:

Horton and Leslie:

It is often defined as the condition which many people consider undesirable and wish to correct.

Lindbergh:

It is any deviant behaviour in a disapproved direction of such a degree that it exceeds the tolerance limit of the community.ⁱ³

To interpret:

"If we look at the definition we can notice that it is something that is undesirable but is there anyway to change this undesirableness and make it desirable?? To guess in this era the only way the citizens think that this undesirableness can be changed is protest. There are certain situations in this society that is completely out of tolerance level but each and every individuals are completely helpless."

And then comes the very vital protest that is nothing but the vicious cycle of **illiteracy** that prevails throughout country. If half or more people are found to be illiterate in a country that is very real that protests will prevail in any such countries and there will be Drastic rise in the poverty level also. As per the 2011 census it was found that about 74.04% were found to be illiterate. If we look at rural areas rather than cities, the rural areas conditions are very pathetic when comes to illiteracy. The governments needs to Set up a good education system in order to revive the people those who strive and protest not only for food but also for better livelihood.

Another major concern and protest that gives rise out of illiteracy is **poverty.**As per the planning commission data the poverty line in the year 2011-12 shown a percentage of 22% which showed 15% decrease as recorded in the year 2004-2005. This figure is expected to decline to 5% by 2022, as per World Poverty Clock estimate. However, 80% of the poor in India live in villages⁴. The poverty is a type of vicious cycle that keeps on giving rise to new
