1. Vashudev v/s state of pepsu (AIR) 1956 S.C 488

The suit is important in this case, a detailed explanation. Has been given of the effect on the criminal ability of drunkenness or intoxication the accused, who was a retired army jamadar, was accused of causing the procession. According to the prosecution. The accused had consumed excessive alcohol and in a state of intoxication, the accused shot the deceased youth when he left, due to which the young man died it was proved on the basis of evidence that though the accused was staggering in intoxication and there was no consistency in his words, yet he was able to walk freely and choose a suitable seat for him to sit there after the murder tried to escape and caught expressing your regrets on leaving etc. Confirms this that he was sufficiently conscious and in a position to contemplate his act, Supreme Court decision The court there fore held that the mere intoxication caused by excessive intoxication would not in itself be considered a sufficient ground for immunity from the offender unless it is proved that by reason of his influence the accused had lost his common sense on the above life imprisonment of the accused was upheld as there was no justification for converting the offense from murder to homicide.

2. Bablu urf Mubara hessian v/s Rajasthan state (AIR) 2007 S.C 697

After the highest court, the highest was regarded that where the appellant had committed the brutal murder of his wife and three daughters and son at night and people consider him to be clever crook and a person of doubt full character, he will not be able to defend the defense of Mattita under section 85 of the Indian penal code especially when these killings immediately

come out of their hose and screaming loudly that he has by pressing the throat. Supreme Court 's decision-the highest court identified that it is compulsory (accused) to rescue mataal under section 85 Indian penal code while caring for that crime,his intention was not to cared crime and he had this knowledge that he was doing whatever he was doing,she is a crime act.he also has to prove it that Matta was cared in ignorance and she did not have any knowledge or information about it after present, the use of five members of his own family was deliberately cared by the appellant, deliberately cared for the throat and that time was in the whole senses.

3. Suresh V/S M.P State 1997

In this case, the Court has just held that the provisions of section 50 of NDPS are Mandatory. The accused was not Searched before a magistrate or a Gazetted officer And no serious measure were taken in this regard Nor was the consent obtained from the search in the Absence of a magistrate or Gazetted officer. In this Case the police officer was obtained showing hostile Relation with the accused such searches were Considered biased.

4. Jarnail Singh V/S State Of Haryana

The negligence of the investigating agency was found In this case the result of this negligence was that the property's identity became suspicious. Yukta was Acquitted by giving him the benefit of doubt.

5. Vinod Kumar V/S State of Punjab 1 June 2012.

It is clear from the above case that if the confiscated material is pure and simple either a narcotic drug or a non– psychoactive substance which falls within the entries in the schedule on basis of weight of the drug substance, it may be referred to as either commercial quantity or, small quantity or as non commercial quantity and accordingly the accused shall be convinced and punished only in ces where the confiscated prohibited material is a mixture with or without a neutral material.

Supreme Court order

In the case of a prohibition substance which is neither a mixture nor a preparation covered by entry number 239 and if the prohibited substance is a Narcotic drug. If the Psychotropic Substances is simple then there is no need for purity testing and in such cases the full dose of the Narcotic drug Psychotropic Substances will be considered to decide whether if is a small quantity or a commercial quantity or an in termediate dose. For the purpose of conviction And punished accordingly.

6. Parmanand and others V/S Haryana December 2013

In case of substance which is neither a mixture nor entry number 239 prohibited substance a narcotic drug Psychotropic Substances is simple. So there is no need for purity test. And in such case the full does of the Narcotic drug Psychotropic Substances will be considered in deciding whether it is a small dose or a commercial dose or an intermediate dose which is for the purpose of acquittal and punished accordingly. DRUG CONTROL OFFICER : And the SMO cannot possibly be held responsible for cannot possibly be held responsible for any motive as he will bring such a large quantity of Narcotic Drugs and psychotropic substances and falsely implicate the accused in the present case.

7. Smt. Kusum Kc (In Jail) V/S State Of Uttar Pradesh 4 July 2013.

Cause Of Narcotic Drugs and Psychotropic Substances Act 1985,(4) section 50 (4) compliance is mandatory Also no female can be traced by man.

Supreme Court Judgement: learned counsel for the has been given in 2013 (1) 677 (P.ED.H) in which it is organized as follows. Narcotic Drugs an Psychotropic Substances Act 1985 S 50 (4) The mandatory provisions of S 50 of the Act of search of a woman by a man was not properly complied with.

8. State of Punjab V/S Gavalu on 5 April 2013.

It may be mentioned that the offence was committed on 31/03 / 1997 and the Act was amended in 2001. All matters pending before the courts or (under) investigation at the commencement of this Act shall be disposed of in accordance with the provision of the principle Act as amended by Act. And accordingly any person found guilty of any offense punishable under the principle act. As it stood immediately before such commencement shall be liable to a punishment which is less than that punishment for which he is other wise liable on the date of committing offense.

9. Niranjn Jayantilal shah V/S Diretorote of revenue on 19 November 2013.

This is a petition filed by the petitioner under Section 439 Cr.P.C. for grant of regular bail. It is submitted by learned counsel appearing for the petitioner that respondent had filed a criminal complaint against the etitioner and others which is pending before the Special Judge, Narcotic Drugs and Psychotropic Substances Cases, Saket Courts, New Delhi being S.C. No. 09A/12 for the offences punishable under Section 9A, 25A and 29 of Narcotic Drugs and Psychotropic Substances Act, 1985 ('NDPS' Act) on the allegations that on 15th December, 2011 on the basis of secret information the officers of Directorate of Revenue Intelligence ('DRI') have recovered and seized 100 kgs. of Pseudoephedrine from a vehicle bearing registration No. HR-18A-0077 and it is alleged that at that time petitioner was driving the said vehicle. Nothing was recovered from the possession of the petitioner or at his instance. The substance in question is neither

narcotic drug nor psychotropic substance but it is a controlled substance as defined under Section 2(vii) (d) of the NDPS Act. Rigour of Section 37 of the NDPS Act is not attracted in the present case. No minimum punishment has been prescribed for the possession of the aforesaid contraband substance. The substance in question has lot many legitimate uses and the said substance is also one of the main component for manufacturing cough syrup and it has many other medical uses.

Earlier a bail application was moved which was dismissed. The petitioner is in custody since 15th December, 2011, as such, he be released on bail. Reliance was placed on Bail Application No. 216/2005 titled as N.C. Chellathambi v. N.C.B decided on 20th April, 2005, Bail Application No. 2036/2004 titled as Ajay Aggarwal v. Narcotics Control Bureau decided on 20th January, 2005, Criminal Misc No. M.27654/2008 titled as Rajiv Kumar @ Sukha v. The State of Punjab decided on 6th March, 2009, Criminal Application No. 165/2011 titled as Faiyaz Ahmed Rasool Shaikh v. Union of India decided on 5th May, 2011 and Chakrapani Dutt v. State CDJ 2006 DHC 528.
