ABSTRACT

In the era of 21st century, the role of mass media and internet plays a vital role for the healthy development of a children in this modern period against the consequences of excessive use in exploring age restricted media. However, internet is both a source of promise for the children where it provides enormous range of positive information related to education materials. Apart from it internet has also have various disadvantages where the children of now a days has become the technology freak, most of time they spend hours to hours time in online exposure in sexual websites and other material due to these misuse of technology it has been the most concerning factor of increasing cyber crime. The mainstream of mass media includes television, magazines, movies, music etc, provides increasing portrayal contents of sexuality. online child pornography has not only become an industry, but also has led to sexual exploitation and abuse of children in worldwide which effected socially, mentally and physically.

In this study, we will examine a recurring pattern of scientific concern regarding sexuality in the media. Furthermore, we will discuss some overarching theories that help us to understand the expression of sexuality in mass media. In such a global society, internet or cyberspace where today's culture, moral and legal variation varies and sometimes it is difficult to define the exact meaning of the term"pornographic".²

Although, there are various organization who are still standing up to fight against the group of criminals who are being involved in the offenses related to minors and out of one of them is the international criminal police organization (INTERPOL), has defined "child pornography as the consequences of the exploitation or committing sexual abuse perpetrated against the child which promotes sexual abuse of child including audio and focused on Sexual practice acts or the genital organs of children.

Throughout the ages, the existence of sexual content has been used to treat for threatening children. However, usage of pornographic videos, images etc in the modern senses, firstly began with the invention of camera in the early 19th century. ³ Although in, 20th century, child pornography remained a restricted activity.Hence, most of the investigations on Internet child pornography have been involved in cooperation among jurisdictions, often at an international level.

However, within this broader strategy, localized police departments have a crucial role to play, because of the growing use of computers in the society and almost all the police departments are likely to fight against Internet child pornography crimes. Henceforth, larger departments or departments established in districts areas may have their own Internet child pornography teams, but almost smaller groups do not, but the responsibility for day-to-day investigations will tend to fall upon the general-duties officers. Internet child pornography is one of the severe problems related to either child abuse or the Internet.⁴

Defining – Child

Child, a future citizen of nation, born with so much of expectations from the world imagining the positiveness culture of the society. In the era of jurisprudence, if a child is still in the womb of its mother, technically he is not a person but in aspect of legality of unborn child, it is considered as already born, he is granted as legal personality. If the child is born alive, he enjoys the legal status under the given Indian legislation's. However, as far as the provisions of the law is concerned, before the child births, although the fetus has the life, they are not treated as the separate living being. ⁵ In India, children faces some of the harshest conditions and more

A child needs a special care and protection so that they can walk in a right path, for the security of the child nationally and internationally, many legislation's and conventions have been brought which defines the child as a "person below the age of 18 years". In the developing countries, the impoverished situation have made the people heartless, in such a tender age children dreams to go school, wants to enjoy their childhood but are forced by their parents to work outside their homes, left them with inhuman condition and hostile circumstances where they are tortured, ill-treated and exploited and forced to be the victim of pornography sector like nothing where they never thought off. ⁶ Due to such vulnerable conditions, the rights of the children has always been ignored from a very long period. According to Indian law, the meaning of "child" will always remains ambiguous. However, so many legislation's and bills, defines the "child" still in the larger context, the confusion still exists upon the age criteria that who is a child, which remains incomplete.

Defining - Child pornography

In a modern context, there has been an expansion in the commercial business of illicit content counting the rise of use of the dark net.Globally, the response and rise of the cases of child pornography in accordance to mass media needs the corrective measures to protect to safeguard the children from being sexually assaulted which the state necessarily requires a cooperative strategy and standardized level of domestic legislation across the worldwide. However, codified and strict legislation plays an important role in protecting the children of our nation from being victimized. Internationally, according to the current federal legal situation in united states, a child is remembered as any person under the age of 18. Recently, a statute was enacted in USA which regulates the obscenity on the internet under Communication Decency Act, 1996, in short CDA, 1996 basically prohibits intentionally and purposefully sending of "patently offensive", material describing sexual activities or organs in any manner which is available to a person under 18 years of age using an "interactive computer service or ICS." Looking into constitutionality of this statute, it was challenged before the supreme court in the leading case⁷, it was argued that the aim of the government should be to protect the children from harmful material but according to the observance of the supreme court, the words of the statute found to be vague and uncertain. However, child pornography was recognized as an

exception to freedom of speech which is guaranteed under the American constitution.⁸

In modern sense, legally the statute includes computer generated images includes virtual images and minor children. Henceforth, in one of the leading case, it was observed that a man was convicted for possessing videos in which the camera focused on the clothed genital region of young girls. ⁹ Pornographic records include static photographs, videos, and audio sound recording. The images themselves vary substantially in their graphic content. In some cases individuals may collect images that do not involve under pornography and are not technically illegal. Under common law, obscenity is taken as the indictable offence which is punishable under the discretion of the court. The test of obscenity which is also known as hecklins test¹⁰ evolved in the England to determine the obscenity, later on USA given up this test but the Indian legislation on obscenity is more or less similar to the American jurisdiction, it states as "Test of lascivious and prurient interests." In Indian platform, the general law of obscenity governs under S. 292 of Indian Penal Code, 1860. Henceforth, the code of pornography on the internet has framed up serious challenges put forwarded before the governments and legislature primarily to look upon the nature of the medium. Due to ease availability, of pornographic materials in digitized format includes video clips, websites with free access and open have made the minds of the criminals more smarter.

India is the hub of modern slavery, where 14 millions of children becomes the victim of child sexual assault, children are abused and exploited by the strangers, friends, family members and other perpetrators. According to 2013 census, the rate of sexual abuse of children is very high.¹¹Henceforth, through years of study according to researchers, Child pornography includes collection of non- sexualize pictures, naked or semi-naked pictures of children, photographs taken in secret of children in which they reveal the level of nudity and erotic standard, posed pictures of children in varying degrees of nudity, pictures of children in sexuality poses varies degrees of nakedness, pictures emphasizing the genitals, record of sexual activity involving children, record of children subjected to sexual abuse involving digital touching with adults, record of children subjected to pain, or engaging in sexual activity with an animal and so on.¹²

II. ROLE OF INTERNET IN PROMOTING CHILD PORNOGRAPHY

In today's scenario, the nation is incomplete without the internet access, due to in every circumstances in every field work or profession the net or broadband connectivity requires. It has become a part of our busy system. But despite of it, Internet has various advantages and disadvantage, and the main disadvantage the worldwide is facing that the Internet has increased the problem of child pornography by exploding the quantity of material accessible, the efficiency of its distribution, and the ease of its approachability. Around the world, generally, cyber networking gives permission to access large quantities of pornographic Images which makes pornographic instantly available at any time or at any place. However, pornographic sites can be accessed anonymously and privately facilitates direct communication and image sharing among users. There are several materials provides images that are of high digital quality, do not deteriorate, and can be conveniently stored in variety of formats i.e pictures, videos, sound, as well as it is potential for real-time and interactive experiences. It also provides access to digital images that have been modified to create composite or virtual images.

In some of the circumstances, the problem of Internet child pornography can be divided into three stages —the production, distribution, and downloading of images. Firstly, the stage of production connotes the creation of pornographic images. However, many pictures currently uploaded on the Internet may be decades old, taken from originally from magazines and films. Images may be produced professionally, in these cases, often pertain in abuse of children in third-world countries. Secondly, distribution involves in uploading and spreading of pornographic images. Child pornography may be uploaded to the Internet on websites or exchanged via mails, instant messages, newsgroups, bulletin boards, chat rooms, and peer-to-peer networks etc. Thirdly but not the least, it involves by accessing child pornography via the Internet where images do not need to be saved to the computer's hard drive to constitute downloading. In some cases, it may be received through spam advertising child pornography, a pop-up link may appear in unconnected websites, or may be. unknowingly go to a child pornography website. Mostly, users must be actively seekout pornographic websites or to subscribe to a group dedicated to child pornography.¹³

III. EFFECTS UPON VICTIM OF CHILD PORNOGRAPHY

Therefore, large majority of children appears to be the victim under the crime of child pornography have not been kidnapped or physically forced to participate but has been trapped

Nevertheless, the subject matter of child pornography may be very terrified and can have devastating effect physically, socially and psychologically on children.¹⁵ The children are depicted in child pornography are firstly victimized when their abuse is perpetrated and recorded. Through slots of fact finding tests, it somehow shows that media has stupendous skills and potential to teach the society, due to which excessive consumption of technology and free access to media have made the society violent, gender-stereotyped, and sexual explicit personality which leaves behind the increases high risk behavior among the children's. ¹⁶ It effects into the human relationship. According to Dr. Cooper, a forensic pediatrician and faculty member at the University of North Carolina School of Medicine, "pornography standardizes sexual harm which portrays lack of emotional relationship between consensual partners, unprotected consensual contract and in some cases, it tends to violation and rape.¹⁷ However, continuous exposure to pornography leaves the negative impact on children and youth of today's generation and with time passes, our future youths are more addicted to pornographic images, sites, age restricted movies and they experience more than the adults.

In later period of time, the victims have reported their initial feelings of shame and anxiety did not fade but intensified to feelings of deep condition, worthlessness, and hopelessness. Their experience had provided them with a deformed model of intimate, and many had peculiar trouble in establishing and hold back healthy emotional and erotic relationships. Children are targeted sexually harassed through net surfing. Pornography promotes hostile behavior towards the women. The aggressiveness and fierceness towards women found much of rough with more of wild pornography can where young boys can learn more easily by watching and male youngsters which is ethically acceptable, and even desirable, to behave aggressively towards and disgrace women. Pornography also picturizes people under sexual relationships that does not precisely reflects how actual people look and act and behave in sexual relationships. Wild expectations of intimate partners may hinder youths' ability to build and maintain healthy relationships.¹⁸ Through, the past examination of the content of pornography ends up assuming

that the typical sexual script focuses on the erotic desires and artistry of men shapes negative attitudes and behaviors in front of women. A continuous exposure of sexual and erotic content affects healthy intimate relationship which reverts back as risk to be addicted for daily observe to access pornographic materials. Sexual addiction by children likely struggles to focus or concentrate in other stuffs which highly impacts the brain functioning system.¹⁹

IV. ROLE OF MEDIA IN CHILD PORNOGRAPHY

The determinative factor of media picturizes of sexual attitudes and normative expectations of young people at a critical developmental stage is of public health concern. Hence, Mass media is designed to be consumed by large audiences through the business of technology. Worldwide, internet has been publicly approachable network of interconnected computer networks that transfers information and services such as electronic mail, online chat, title transfer, interlinked web pages, and other documents of the World Wide Web.²⁰ In 1981, Media influenced upon sexual behavior was firstly reported in a newsletter about sex education. There was a significant relation between sexual activity, and time spent watching television, and the often using of Internet, spent more time watching television and those who used the Internet more frequently were more likely to be sexually active.²¹The exceptional broadening of mass media during the late 20th century, and especially the establishment of the Internet, has immensely increased the approach-ability to pornography and other sexually-related information. This constructs a major hurdle to the healthy development of sexuality, particularly among youth. Adolescents often strikes pornography accidentally on the Internet. One survey found that 70 percent of teens aged from 15 to 17 fortuitously came across pornography online.²²

However, diversifying factors forecasts an adolescent's use of pornography. Teenagers and youngsters whose mind is always in search of pornographic sites and related articles are more oftentimes incline themselves to be the high sensational seekers, less satisfaction with their lives, assures fast Internet connection, and have friends who are younger.²³Adolescents are at greater risk for deliberately searching out sexual material where there usage of internet connectivity is at very advance level.²⁴ Both boys' and girls' have different rationale for

V. JUDICIAL RESPONSE TO COMBAT CHILD PORNOGRAPHY

Child pornography is a modern crime. Children in a tender age are found to be innocent however they can be easily trapped by the criminals. Children are targeted more often. It portrays the minors and youngsters who appears to be sexually explicit act by the mode of videos, photographs, or through other content due to such act young minds are being mentally and physically harassed. Now-a-days, through social media, young girls and boys uploads lots and lots of pictures and their stories which is in trend, but on the other side, criminals tampers those pictures and modifies in such a way that appears to be erotically clear act which is considered to be child pornography. In 1998 till last year, the registered cases have increased in every decade. In the year 1998, 3000 cases were registered against the porn websites and later on it increased to 100, 000 cases. In the year, the number of cases exceed to 1million and in 2019, the number of cases went above the expectation, it cracked the level of 18.4 million reported cases. Few years back, a study was conducted by the UNICEF, where in every 1 out of 3 girls and 1 out of 5 boys are sexually assaulted before they reach to the age of puberty, and some children commits suicide and some take doses of pills for the depression. 90% of children know their offenders.

According to National Centre For Sexual Abuse (NCFSA), child pornography is one of the successful industry growing at par through online business and commercial propaganda. In India, in every 40 seconds a new pornographic video is being uploaded and 38% of the victims are linked to child sexual abuse. According to US National Centre for missing and exploited children (NCMEC) and National crime records bureau(NCRB) observed that around 25, 000or more pieces of alleged child sexual content have been uploaded in every seconds in social media platforms in India over in the last 5 months after the outbreak of Covid-19.

Under international judicial forum, a treaty was legally binded for the protection of rights of children from sexual abuse under the United Nations Conventions on rights of the child. Following the convention under Article 34 of the convention, puts obligations upon the state to under take all the measures for the protection of children from all forms of sexual exploitation. In 2000, the United Nation general assembly adopted optional protocol on the sale

of children, child prostitution and child pornography. This universal treaty deals with the issue of sexual abuse of children also recognizes the rights of the victims of crimes, it also laid down the points which highlights the protection of victims under criminal justice system. Under Article 3(1)(c) approves that the state to punish the possession of child porn if it is distributed for any purpose. According to Budapest Convention, this convention deals the child abuse in a more pragmatic approach. Under Article 9 of the convention, defines child pornography states that a material that is visible depicts a minor child and is forced to be engaged in a sexually explicit act.

Under Indian criminal justice system, the applicable statutes is valid for the cases of child pornography under Indian penal Code (IPC), Information and Technology Act, 2000(IT act) and Protection of children from Sexual Offenses Act, 2012(POCSO Act). Under the following applicability, Section 293 of IPC specifically prohibits the sale, distribution, circulation of any material defining obscenity indicates to any person below the age of 20 years and considers the act as a cognizable offense. In Indian scenario, Information and Technology Act is the keystone of cyber laws and under Section 67(B), of the act forbids child pornography but the storage and consumption of child porn shall be punished before the eyes of law. Under the POCSO Act, Section 14 of the act, bans the use of children for pornographic purpose in any form of media includes portraying child sexual organ, forcing to participate in real erotic activities etc. However, child pornographic material bars for commercial purposes.²⁶

The expeditious growth of internet and media has out turn the rise and ease of use of child pornography in Indian context. In highlight to above content, growth of cyber crime has kept the situation shaken but with the proper initiative taken by the Indian Government has enacted various legislations and reforms to strengthen the legal frameworks regarding illegal use of children for pornographic websites. According to data, till 2020 around 857 porn websites have been banned in India due to strong demand of porn and psychological concerns have forced the government to take such action and tough measures to block the porn sites because of the increasing cases of child pornography.²⁷

This decision was taken under the Information Technology Act and in consonance with Article 19(2) of the Constitution of India that permits the Government to impose restrictions on the grounds of conventionality and morality. Notwithstanding, this complete boycott was subsequently lifted and only implemented on those sites containing child pornography. This

Surfing of Adult sites has been the worrying trend but due to the global outbreak of corona virus, impose of lockdowns, and social distancing, children started finding more interest and instant pleasure in erotic content. However, increasing of Traffic on Pornographic sites is not the only set of concern. The main reason behind the burgeoning usage of sites is because of closed schools and colleges all over the country, and students are left with more free time on their hands, for easily access of sites many are available online with free subscriptions that can be watched during the online classes through any devices. The Indian organization has to date banned more than 3, 500 pornography sites in the country. However, India positions third on the planet, trailed by America and Britain, as far as burning-through pornographic content.²⁸

"There is no sign that individuals created monstrous pornography issues, or that pornographic addiction turned into an problem for more individuals, " says Grubbs, a sexual science researcher and addiction specialist. "It simply appears as though individuals were exhausted at home, most likely saw pornography at first, and afterward chose, 'OK, indeed, I've done what's necessary of that, so now it's an ideal opportunity to go prepare some sourdough bread."²⁹

During the COVID-19 forced lockdowns across the world, the web offered never ending interruptions for individuals compelled to remain at home. An study led on subjects more established than 60 showed essentially expanded internet use with a 64.1% rise in use of online communications applications like Zoom/WhatsApp and a 41.7% rise in utilizing the web for day by day tasks, showing how even moderately aged subjects and more seasoned grown-ups who were not spending quite a while on the web beforehand, have been semi compelled to receive online exercises on account of different pressing factors, for example, the change of on location work environments to web based work-from-home conditions and the need to remain refreshed with COVID-related news and family.

The COVID-19 lockdown converted into physical isolation, driving people to sit around online with no distinct reason, spending longer, strange lengths of time online when exhausted, prompting expanded utilization of online erotic entertainment. In 2019, Pornhub, one of the world's biggest explicit video-sharing sites, receiving 42 billion visits—about multiple times the total populace. Yet, the pandemic appears to have caused a considerably more keen and

more observed traffic for hours on explicit sites. Pornhub has shared demographics on a regular basis revealing the changes and newly trends in the consumption of their content, showing a constantly positive deviation from average traffic before pre -pandemic. An examination utilizing Google Trends and joint point relapse investigation exhibited a critical rise in interest in explicit sites in nations with "stay at home requests". ³⁰

VII. CONCLUSION

Different reports and documents examines the magnitude upon the safety towards children surfing on the internet mainly focusing on internet and media pornography. The objectives of this study includes ensuring the stage to which children or peer relationships influences their internet access. Determining the impact of sex and erotic nature up on student and use of internet for social networking, Email etc. Contribution of use age of internet for video posting/viewing.Ascertaining the level of children exposing to free online pornography. The result of the present study found that majority of children do not have access to internet through peer relationships which implies that the extent to which children peer relationships influence their internet access is low. The result also revealed that sex has significant impact on student use of internet for video posting/viewing but does not impact on student use of internet for instant messaging. This result connotes that the students use the internet for social networking, video posting/viewing, and Emailing but do not use it for instant messaging and in doing their homework. Hence, it should be remarked that the few children who use the internet for these activities are at risk of being exposed to pornography online. However, the internet is a source of promise for children no doubting this is because it offers an enormous range of positive and educational experiences and materials.

On the other hand, the internet is a source of concern for children and they may be exposed to inappropriate material that is sexual, and hateful in nature. Child pornography is not the legal issue its a moral as well as social issue. Analysis submitted by the The international Centre for Missing and Exploited children(ICMEC) about the child pornography laws is applicable in 184 INTERPOL member countries and found that half of the legislation's had not directly addressed the problems of child pornography. As till now, only 45 countries in the world have more of comprehensive laws to combat child pornography.

Despite of having international conventions as a worldwide gathering, have had setbacks in chalking out determinate guidance for their implementation. A comprehensive global framework for the spotting, assessment, and prosecution of online child pornography is the
