III. MALE RAPE VICTIMIZATION IS REAL

In 2022 a case of male victimization of rape was witnessed by the country. In Jalandhar A man was raped by Four women, flabbergasting, is not it, how can a man get raped, some might think it as a shameful act while some might think how lucky that man was; the reality of the hypocrite society we live in is utterly grotesque and maybe some would never accept the fact that a man could get raped.

In 2017 in Mumbai, a 13-year-old boy was raped in Powai and another 16-year-old was raped,

sexually exploited, and physically abused by 15 other boys for a year, the shocking incident was confirmed by a medical examination. In Madras a student aged 12 years old was sexually violated by his teacher.

Age is one significant attribute of rape cases; it is seen that younger men are more prone to become a victim than older men. By the statistics stated above it is coherent that men between the age 10-20 have more chances to being a victim.

In most of the male rape cases it was found that either the perpetrator knew the victim already or was somehow connected or linked to the victim, thus it could be concluded that proximity of relation is another attribute of rapes.

IV. REVISION OF EXISTING RAPE & SEXUAL ASSAULT LAWS

According to the Law an offender shall be punished in order to make him realise his crime and to set up an example for the persons who share similar perspective same as the offender, so that the similar crime or offence is not practised any further.

The existing Laws and rules regarding rape and offences against body are certainly vague, incomplete and outdated. It was not until 2013 that the rape laws were modified to be strict and made strictly followed, only after several repeated incidents, the legislation thought upon the establishment of Rape laws which were relevant according to the present needs and circumstances.

The need to modify these laws and rules has emanated once again, we have rape laws for women and females per se but no law has been designed specifically for men.

The section 375 and 377 of The Indian Penal code,1860 does prescribe the conditions and acts which tantamount to Rape against women and incarnal intercourse with men and animals respectively, however neither of these sections specify the conditions, acts or circumstances that constitute rape against men, therefore, the legislative body of union should take this matter into consideration.

V. CONCLUSION

What society is going through is agonizing and detrimental. The legislation should investigate in the matter and make the necessary requirements in contemplation of protection of the dignity of citizens, safeguard the human existence and to ensure proper and orderly practise of basic human rights of the individuals.

The members of society need to destignatise the victimization of male rapes as it is real and it happens, people simply need to acknowledge this fact. We need to accept this incredulous fact

and find measures to set up as to provide aid to the male victims in the same manner as law does for females.
